## Preamble

The Cessnock District Netball Association (CDNA) is a not-for-profit organisation that strives to provide opportunities for everyone in our community to participate in healthy, safe and inclusive netball activities in a fun and family orientated environment.

The Association is managed by dedicated volunteer staff, all of whom tirelessly provide their skills, time and assistance to ensure CDNA can offer a variety of structured programs.

We are committed to developing a sporting culture that is based on integrity, innovation & teamwork.

## Purpose

The CDNA Jurd's Real Estate Representative Scholarship Program aims to encourage and empower talented young athletes facing financial hardship by providing \$500 scholarships to TWO players aged 12-18 years old in 2025, that have been selected to represent Cessnock District Netball Association at the State Titles.

Providing support to members whose financial circumstances would otherwise preclude them from participating.

The scholarship will alleviate the costs associated with travel and participation because at CDNA, we believe that *your ability to play netball shouldn't depend on your capacity to pay for it.*

The CDNA Jurd's Real Estate Scholarship Program will provide funds for TWO individuals, to enable their participation in Representative netball at CDNA. Areas of assistance can include, but not limited to:

- Purchase of uniform items
- Payment of Registration / Carnival / State Title fees
- Purchase of suitable Netball playing shoes
- Payment of accommodation & meals associated with attending lead-up carnivals
- Other similar or relevant expenses



## **Eligible Applicants**

- Players aged 12 - 18 years old in 2025
- Registered with Cessnock District Netball Association
- Have been selected in a CDNA Representative team for the 2025 season.
- Be an Australian citizen or permanent resident of Australia
- Meet any CDNA application deadlines. No late applications can be considered.
- Currently qualify for a government issued healthcare card (if applying for Low Income Subsidy)

## **Privacy**

All information collected during the CDNA Jurd's Real Estate Scholarship Program application process will be used by CDNA to assess your application for funding and to perform functions relevant to the administration and conduct of CDNA.

The collection and use of personal information by CDNA is governed by the Netball Australia Privacy Policy that has been adopted by CDNA.

## **Scholarship Amount**

Successful applicants are eligible to receive an amount of \$500.

A maximum of 1 scholarship per year can be awarded to an applicant.

## **Categories**

- 1.Low Income Subsidy: The applicant must be the holder of a government issued healthcare card.
- 2.Family Selection Subsidy: The applicant has 2 or more family members selected in a Representative team with Cessnock District Netball Association.
- 3.High Performance Subsidy: The applicant has been selected in a Hunter, Regional, State or National team or development program.
- 4.Financial Hardship Subsidy: The applicant has financial or family circumstances that could restrict them from playing at Representative level if the scholarship was not received.

## **CDNA Jurd's Real Estate Scholarship Review Committee**

The Scholarship Review Committee shall:

- Be made up of one management committee representative (appointed Chair of the Review Committee) and two independent CDNA members.
- Attend the CDNA scholarship meeting as set down by the Chair.
- Consider and discuss all applications.
- Vote to allocate scholarships appropriately.
- Scholarship recipients will be advised in writing by CDNA Secretary.



## Conditions

- Individuals can re-apply each year, regardless of the outcome of their application the previous year.
- The applicant must prove registration when applying for a scholarship.
- Recipients must use all the money awarded from the scholarship to fund their participation in CDNA Representative activities.
- For direct payment, recipients are required to provide a tax invoice that payment can be made on.
- For reimbursement, recipients are required to provide a tax invoice for the expenditure amount.
- For uniform items, Association may provide an invoice, in the applicant's name, for the scholarship to be paid direct to the Association.
- Scholarship monies for registration fees will exclude any Government funded vouchers used for registration or purchases.
- Applications will be assessed by the CDNA Jurd's Real Estate Scholarship Program Review Committee.
- Approvals will be subject to an annual scholarship budget until the funds are exhausted.
